Rain, Rain, Come our Way!
With virtually no "April Showers" we can only hope that May will bring some much-needed rain. But in the meantime, city and county
WATERING RESTRICTIONS remain in

effect. This means one (1) authorized watering day per week according to your unit number. Please refer to the City of Tarpon Springs schedule of watering days/times in this issue. And REMEMBER: Residents should NOT be IRRIGATING LAWNS on Saturdays and Sundays. If you need assistance to re-set your system to your authorized day and time, please call, or email the Office.

BUSTLING APRIL

Overall, April was a BUSY month: tree trimming, well fixing, critter trapping, paper shredding, updating! Maybe that's why it seemed to fly! The new office hours for resident services (8AM -12 Noon) have been extremely helpful in providing time in the afternoon for tasks that need concentration and focus. I appreciate your flexibility and the increased use of office email and the drop box. **Coming soon:** Resident Forms will be available OUTSIDE of the Office in the main hall for even greater convenience and ease of access.

Here's a recap of the many things that were tended to in April...

- -Lawn cutting transitioned to once a week, now through the beginning of October.
- -New code-compliant Life Buoys were added to the Pool Area.

- -New Pool Umbrellas and two new tables have been ordered.
- -Park-wide Tree Trimming was completed.
- -Well 172 Pump was replaced, as was the control box at #128.
- -Well #212 is slated for a new meter and #49 is scheduled for Electric maintenance.
- **-1800 Pounds** of paper were collected for Shredding at our April 12th Event.
- -A **Shuffleboard Policy** was approved and adopted by the SRI Board and appears in this issue.
- -Asphalt patch repair at rear parking lot has been scheduled for MAY 5.
- -Painting and re-striping of Shuffleboard Courts is board-approved and being scheduled.
- -DOT has made repairs/improvements at the road's edge at outgoing US 19 Exit.
 Improvements are also in progress to the sidewalk south of the entrance.

DETERING UNWELCOME GUESTS...

Recently, a black spine-tail Iguana needed to be ousted from under a unit. To prevent such critters from taking up residence under your unit, experts advise to CHECK FOR ANY ACCESS POINTS – spaces between blocks, torn screening, and such – AND ELIMINATE THE POTENTIAL ENTRY POINTS.

exterior will also deter other nuisance wildlife. This includes removing bird feeders, pet food, trash bags, and fruit on trees/ground. Please check that you are not providing food sources of any type that could be attracting nuisance wildlife. For this reason, Bird Feeders are highly discouraged and should be removed.

LAWN SIGNS, ORNAMENTS, LIGHT POSTS? ... BOARD ACTION!

As explained at the April 26th SRI Meeting, it's been observed by the Board that there are lots in the park displaying Signs, Light Posts, and/or Garden Ornaments on the grass which conflict with the Rules and Regulations of Stonehedge. Signs, lights, garden ornaments, staked banners, INTERFERE with GRASS MOWING, and increase the likelihood that mowing equipment will be obstructed and/or cause damage to irrigation parts and equipment or your unit.

The Board advises that residents check their lots for any Signs, Light Posts, Garden Ornaments, staked Flags/Banners and REMOVE them from the grass. This is also a very timely reminder as we move into TROPICAL STORM & HURRICANE SEASON. Be aware that Lots that continue to display the items mentioned above after the end of this month, will be subject to enforcement as outlined in the Rules and Regulations of Stonehedge. Decorative ornaments in flower beds or affixed to a wall may remain.



Please check your outside patios, carports and porches for items that should NOT be

on the exterior as required by the Stonehedge Rules and Regulations. Any such items, as well as any that could become PROJECTILES in a high wind event or Hurricane, need to be removed. 'Tis the season to STORE AWAY such items.

Managers Reminders...

Please, ALWAYS CLOSE UMBRELLAS at the Pool Patio when leaving the area.

-Did you know that, as per the Rules & Regulations of Stonehedge (General, # 3), "Payments postmarked after the fifth (5th) day of each month are considered delinquent and subject to a late charge." Best way to avoid late fees for LATE PAYMENT? Enroll in AUTOPAY! The form is in this issue.

- -Thank you!! Calls and concerns about parking on the Sidewalks have dropped considerably.
- -And then there were two! The 3rd dumpster has been removed. Please continue to follow the **Dumpster Use Rules** ... **And remember**, **dumpster area is video monitored**.
- -Please be aware of a CHANGE to the REQUEST TO MAKE ADDITIONS OR CHANGES form. The change REQUIRES OWNERS to provide a COPY of the CITY or COUNTY PERMIT to the Stonehedge OFFICE and DISPLAY IT AT THE UNIT for projects that require such Permitting. Updated forms are available at the Office and will be available soon at stonehedgeonthehill.org. Please begin using the most recently revised and approved form dated 4/26/23. The revised form appears at the back of this issue.







Stonehedge Shuffleboard Usage Policy

Shuffleboard Courts are available to all Residents of Stonehedge.

- Residents with guests may play at any time when courts are not in use.
- Guests seeking usage of the shuffleboard courts without Resident presence must receive approval from the Park Manager.
- The Park Manager will be in contact with the Court Master regarding availability and usage/scheduling of courts for resident guests.

Residents are responsible and accountable for court usage by Visitors and Guests. Children under 16 years of age need to be under direct adult supervision.

- No activities should take place other than shuffleboard, without Park Manager approval.
- No rollerblading, bikes or skateboards allowed on courts.
- Normally courts 1 and 6 will be only utilized by Resident guests and visitors.
- There is no playing on wet courts.
- Discs and sticks are available in the Shuffleboard shed; Court Master may assist with preparation of courts before usage.

Residents are responsible for returning courts to proper condition which includes sweeping courts, returning discs and sticks to proper location, and removing all trash.
