Treasurer's Report: Treasurer Thomas enumerated work being done in-house in an effort to save money. Thomas read the financial report. A motion was duly made and seconded to approve. Motion unanimously approved.

Committee Reports: Committee reports will be quarterly unless a meeting is current. Committee Chairpersons and members names are on file in the office and in the Beacon Newsletter.

Committee Reports: (Only reported quarterly.)

- a) Rules and Regulations, Chair-Dunstall read two proposed rules to be voted on at the Annual Meeting: one regarding dogs from the Committee and a petition for a motorcycle rule change.
- b) Maintenance, Beautification, Risk Management, Chair-Lucas reported the committee met January 12. Lucas presented a list of maintenance issues that are the Parks responsibilty that needed attention. The committee will be making a survey of homes to make note of any necessary sprucing up that is needed. Lucas requested input regarding a use for the picnic area.
- c) Long Range Planning, Chair-Ellingson has a meeting scheduled for Feburary 16th at 9 a.m.
- d) Architectural, Chair-Kinsey reports they have had forty plus architectural change requests, some caused by the hurricane. There were a few color tweaks. This a small, three-member Comittee. Kinsey also announced he will be gone February and March, so Lois will accept emergency calls in his absence.
- e) Budget Committee, Chair-Thomas reports a Budget Town Hall style meeting on January 13 with a count of 65 attendees. Hopefully the results of the meeting were good, see the posted minutes. At month end Tony will have a long-range plan for the 2019 budget out for review.

Manager's Report:
