**Old Business -Discussion/Action Items**

- **Open Carry:** Thomson; A resolution of all Board of Directors regarding firearms on association property. Whereas the Master Occupancy Agreement of Stonehenge Residence Incorporated establishes that the Board of Directors is responsible for the operation of the common areas and association property subject to the Master Agreement. And for the enforcement of its rules and policies on matters of common interest to its residents. Whereas Article 5 of the Master Agreement provides that residents have the right to joint use and enjoyment of the common areas and property of the association. Whereas the Board of Directors have a fiduciary duty for the safety and welfare of the association residents and

seeks to balance the interests of all residents in a safe manner. Master Agreement and Article 11 of the bylaws grant the Board of Directors strong rulemaking authority as it pertains to the association property. And whereas, this policy supersedes and replaces all prior policies with respect to the matters referenced herein.

Now, therefore, be it resolved by the Board of Directors as follows. No firearms are permitted on the common areas of the associated property. No nuisance use, threatening, or aggressive exhibition or illegal use of a firearm is permitted while on association property. Residents are solely responsible for any injury or damage resulting from the discharge of a firearm while on association property, whether it is negligent or intentional discharge. Residents are responsible for ensuring that all guests, invitees, and licensees comply with these restrictions, and residents shall be solely responsible for any unauthorized or illegal firearm conduct by their guests, invitees, and licensees while on association property. Nothing in this resolution shall be construed to prohibit residents from lawfully possessing firearms in their unit, or from utilizing the common areas to facilitate safe transport to and from their vehicle. When necessary, the Board of Directors has adopted this resolution.
